1.0 INTRODUCTION

Indraprastha Gas limited (IGL) (hereinafter referred as “Purchaser”) is a leading natural gas retailing and distribution company and is a joint venture of GAIL India Ltd., BPCL and Govt. of NCT of Delhi. It is supplying Piped Natural Gas (PNG) to domestic, commercial and Industrial consumers and Compressed Natural Gas (CNG) to automobiles through steel / PE pipeline networks in NCT of Delhi & NCR along with geographical areas in UP, Haryana and Rajasthan state.

2.0 BRIEF SCOPE

2.1 SUPPLY AND SITE SERVICES

Design, Engineering, fabrication, assembly, shop testing, supply, installation, commissioning and performance testing of CNG Car dispensers along with Junction Boxes and providing all related services on Annual Rate Contract (ARC) basis. The ARC shall be valid for 1 year period from the date of issuance of LOA/First Notification of Award and shall be delivered as per PO on written intimation of CNG Car dispensers for consumers of CNG & CITY gas distribution project of IGL.

2.1.1 "Inspection: Third party inspection by certifying agency has to be considered for all bidders.”

2.1.2 Installation, testing, commissioning and Performance Acceptance Test of each dispenser package after intimation from IGL.

2.2 ANNUAL MAINTENANCE (REPAIR AND COMPREHENSIVE MAINTENANCE PORTION)

2.2.1 Repair & Comprehensive Maintenance shall be required during Warranty Period & four years after Warranty period.

2.2.2 Comprehensive Maintenance Services during Warranty Period & four years after Warranty period inclusive of consumables and Spares.

4.0 TECHNICAL REQUIREMENT

4.1 The bidder shall be a manufacturer of CNG Dispensers.

4.2 The CNG dispensers model offered by the bidder for supply under this bid must have valid PESO (India) certificate.

4.3 The model of CNG dispensers, offered by the bidder for supply under this tender, must have valid model approval, valid license for manufacturing, valid license for Dealer and Repair from Legal Metrology Department (W&M) India.

4.4 The bidder directly or through their authorized agencies, should have full-fledged service support set up in India or have appropriate arrangement for the same with the established reputed service providers in India fulfilling this criterion.

4.5 For offered dispensers, bidder shall provide *undertaking of following on letter head duly signed by competent authority of bidder/ OEM:*

- a) The proposed Dispenser must have compatibility for automation / SCADA connectivity.
- b) The bidder must have single point responsibility for manufacturing, supplying, installing, and commissioning of dispensing system.
- c) The offered dispensing system shall be of proven make from manufacturer's existing production range and must meet performance requirement as defined in the tender document.
- d) The bidder shall have capability and facility to Design, Engineering, Manufacturing, Testing and Site commissioning of CNG dispensers.
- e) For the proposed Dispensers factory / works; the "Factory assessments Reports" issued by third party inspection agency.

INTERESTED VENDORS ARE REQUIRED TO SUBMIT THEIR EXPRESSION ON A COVER LETTER ADDRESSED TO HOD (C&P AND STORES), IGL ALONG WITH REQUIRED DOCUMENTS AS PER 4.0 ABOVE AT IGL BHAWAN ON OR BEFORE 7TH DECEMBER 2023 LATEST BY 1430 HRS IST.

THE SHORTLISTED VENDORS SHALL BE CONTACTED SEPARATELY FOR FURTHER ASSESSMENT.

NOTE: As this RFQ is for new vendor development, vendors who have already participated in IGL for supply of CNG Dispensers before are NOT eligible to apply.
